Remarks

This Authorization supersedes approval number EASA.210.10075781 dated 04/03/2021 to include additional compatibilities.

The equipment has provisions for an Emergency Breathing System (EBS P/N 1059068) and a Personal Locator Beacon (PLB P/N 1079603 or 1079650) which provide additional functionalities (see below) acceptable on a non-interference basis on the equipment level but specifically not approved under this Authorization.

Limitations:

The life jacked is approved to be used in combination with VIKING immersion suits PS4043, PS4053, PS4054, PS4055, PS4056, PS4036, PS4148, PS4044 and PS4045 or without immersion suit, and in combination with ETSO approved EBS P/N 1133396 EBS Aqualung MEER LW (AP01005).

The life jacket includes additional functionalities, specifically STASS Aqualung LV2 EBS P/N 1059068 and Viking MSLD PLB P/N 1079603 or 1079650.

Additional Functionalities:

Additional functionality as listed in the DDP is not covered by the above mentioned ETSO standard(s) and is accepted on a non-interference basis.
