

This is PPE of category III, subject to regular checks in accordance with article 19 of the European PPE Regulation. In agreement with the manufacturer's choice audits of the production process shall be carried out to assess the Conformity of type (Module D). The manufacturer must be able, on request, to present the audit report. A first audit shall be performed at the latest on 31 Dec 2022 and at least be repeated with intervals of one year.
